AACRN RECERTIFICATION PROTOCOL

POLICY:

HANCB has developed protocols for recertification requirements to ensure AACRNs have continued to maintain competence and/or expand their HIV knowledge base within the four (4) year certification/recertification period. Recertification protocols will be reviewed at least once a year to determine if the requirements are complete and meet the goals of maintaining competence and/or enhancing HIV nursing practice.

PROTOCOL:

Certification Renewal by Continuing Nursing Education (CNE):

- Continuing Nursing Education (CNE) recertification includes a wide spectrum of continuing education activities performed
 by the HIV nurse. It includes both formal and informal education experience for the HIV nurse. CNE are also granted for
 other activities such as HIV publications, presentations, and volunteer/leadership responsibilities.
- AACRN certification renewal by CNE is obtained by accumulating a total of **90 CNE** within a 4-year period. A minimum of 45 CNE in Category I is required. The remaining 45 CNE can be accumulated in categories I IV, although there are limits to the number of CNE accepted in each of the remaining categories (II through IV).
- CNE must be accumulated during the 4-year recertification period. CNE obtained prior to initial AACRN certification cannot be applied towards recertification. Only CNE obtained after the date of initial certification can be applied towards recertification. A description of the acceptable continuing education activities can be found in Appendix A.
- HANCB will randomly audit a certain percentage of AACRN recertification applications. If audited, you will be asked to submit copies of certificates and other documents, as described in Appendix A, verifying your CNE activities with your renewal application. During each 4-year period, all AACRNs are encouraged to keep all documentation and be prepared to submit it upon request if audited. All applications are subject to audit at the discretion of the HANCB. Finally, non-audited AACRNs may be required to submit supporting evidence of recertification requirements at any time.
- It is important to notify the HANCB of any change in address and/or name. It is the responsibility of the renewing AACRN to submit all required documentation at the time of renewal. Failure to submit documentation as required may delay recertification.



APPENDIX A

Continuing Nursing Education activities approved for AACRNs

Category I - HIV Nursing Continuing Education

Description of Activities:

This category includes HIV and AIDS nursing programs granting contact hours or CNE. These programs must address topics that have direct application to the nursing care needs of persons living with HIV or their significant others.

- All 90 CNE may be obtained in Category I.
- A minimum of 45 CNE in Category I are required per four-year period. All courses must be taken during the current certification period. Courses taken during the month of certification/recertification will be allowed. Any courses taken during an extension period for the previous renewal period will not be allowed.
- One contact hour (50 minutes of actual classroom time) equals one CNE.
- If audited, a photocopy of the continuing education certificate is required. The certificate must include the name, date(s) of attendance, title of course, number of contact hours granted, and accrediting agency.

All CNE must be accredited by:

- a state board of nursing
- Accreditation Council for Continuing Medical Education (ACCME)
- AIDS Education and Training Center (AETC)
- American Academy of Nurse Practitioners (AANP)
- American Medical Association (AMA)
- American Nurses Credentialing Center (ANCC)
- Association of Nurses in AIDS Care (ANAC)
- or the international equivalent of these organizations

Accrediting agencies for each course must be listed on the application form.



Category II - Other Nursing Continuing Education

Description of Activities:

This category includes continuing education credits in nursing that are not HIV related.

- A maximum of 18 CNE can be earned.
- One contact hour (50 minutes of actual classroom time) equals one CE.
- If audited, a photocopy of the continuing education certificate is required. The certificate must include the name, date(s) of attendance, title of course, number of contact hours granted, and accrediting agency.

All CNE must be accredited by:

- a state board of nursing
- Accreditation Council for Continuing Medical Education (ACCME)
- AIDS Education and Training Center (AETC)
- American Academy of Nurse Practitioners (AANP)
- American Medical Association (AMA)
- American Nurses Credentialing Center (ANCC)
- Association of Nurses in AIDS Care (ANAC)
- or the international equivalent of these organizations

Accrediting agencies for each course must be listed on the application form.



Category III - Academic Credit Courses

Description of Activities:

This category includes formal academic courses offered by an accredited college or university.

- In the semester system, one semester credit or semester hour is equal to 15 CNE. A 3-credit semester course is equivalent to 45 CNE.
- In the quarter system, one quarter credit, one quarter hour or one credit equals 10 CNE. A 3-credit quarter course is equivalent to 30 CNE.
- In the trimester system, one trimester credit equals 12 CNE. A 3-credit trimester course is equivalent to 36 CNE.
- An unlimited number of applicable CNE can be earned. However, a maximum of 45 CNE can be applied towards recertification since 45 CNE must be earned in Category I.
- If audited, a photocopy of formal transcript or grade report is required. A course description, course content, or syllabus should be included.

These courses should address the biopsychosocial knowledge required to practice HIV professional nursing.

Courses should have clear applicability to HIV practice.

Examples of academic courses applicable to this category include:

addictions

pathophysiology

cell biology

research methods

epidemiology

statistics

• immunology

virology

mental health

Undergraduate/graduate nursing courses related to HIV, physical assessment, differential diagnosis, or pharmacology are also applicable.

Pre-requisite nursing education courses are not acceptable. Examples of courses which are NOT acceptable include, but are not limited to, the following:

- art
- biology
- chemistry
- English
- health care management
- history

- human anatomy and physiology
- math
- music
- philosophy
 - psychology
- sociology



Category IV - Professional Activities

Description of Activities:

This category includes a variety of professional activities in which HIV nurses are involved. Acceptable activities in Category IV include publications, presentations, and volunteer activities. These professional activities should have clear applicability to HIV nursing. A maximum of 15 CNE can be earned per four (4) year renewal period.

Publications:

Publications include professional nursing articles for which the AACRN was author, co-author, or editor. CNE for joint authorship are determined by dividing the number of CNE to be awarded by the number of authors.

- A maximum of 15 CNE per renewal period can be earned for publications.
- If audited, a copy of the article or journal; research publication; title page and/or table of contents of the book are required. Publisher's notice of acceptance can be submitted if publication is pending at the time of recertification; however, credit will not be given for this same publication in a subsequent recertification period.

Examples of activities and maximum CNE related to publications include:

- HIV related editorial in a nursing journal, 2 CNE
- Original HIV related research article, 5 CNE
- HIV textbook editor, 10 CNE
- Chapter in an HIV textbook, 5 CNE
- Authored HIV textbook, 10 CNE
- HIV related journal article, 5 CNE



Presentations:

Presentations include professional nursing presentations where the AACRN delivered HIV information to nurses, other health care professionals, or the public. The presentation must be delivered within the context of a teaching/learning setting. A presentation includes an in-service, seminar, workshop, or conference. CNE for joint presentations are determined by dividing the number of CNE to be awarded by the number of presenters.

- A maximum of 15 CNE per renewal period will be granted for professional presentations.
- If audited, the following must be submitted: evidence of participation in the presentation (i.e., brochure, announcement, or written statement).

Examples of activities and maximum CNE allowed for presentations include:

- 2 CNE for each contact hour (50 minutes) of lecture material presented.
- A repeat presentation will be granted 1 CE for a maximum of 1 time within the current renewal period.
- A 50-minute presentation that is repeated once (one original and one repeat presentation) would be granted 3 CNE.

Grant writing:

Grant applications may be for clinical care, educational programs, or research activities.

- A maximum of 5 CEs will be granted for grant writing activities for HIV programs.
- If audited, a copy of the grant submission letter or notice of funding will be required. An example of CEs assigned for grant writing is the completion/submission of a grant application (5 CEs).



Category V - Volunteer Activities

Description of Activities:

Recognizing the leadership role many AACRNs have in HIV nursing, CNE can be earned through volunteer activities with an established HIV volunteer service or non-profit organization. These activities may include committee or taskforce involvement at the local or national level. A maximum of 15 CNE per renewal period can be earned in category V for volunteer activities.

Regardless of whether you are being audited or not, the following must be submitted to earn CNE for volunteer activities:

Evidence of participation in the volunteer activity (written verification from the sponsoring organization).

For precepting activities:

• A written letter from your immediate supervisor or faculty liaison stating the number of hours precepted and the purpose of the precepting experience (orienting new staff nurse, precepting undergraduate community health student, etc.).

For volunteer nursing activities:

- Written documentation of the volunteer organization's (non-ANAC and HANCB) values and mission statement.
- Written documentation from a program sponsor verifying evidence of participation in the volunteer activity, including the number of volunteer hours completed.



ANAC and HANCB volunteer activities

- Serving as an HANCB Board Member, 7 CNE per year.
- Serving as a national ANAC Board Member, 7 CNE per year.
- Serving as a local chapter ANAC Board Member, 3 CNE per year.
- Serving as committee chair on an ANAC national committee, 3 CNE per year.
- Participation on an ANAC national committee, 2 CNE per year.
- Participation as a JANAC or other HIV related manuscript peer reviewer, 2 CNE per year.
- Participation in a local/regional/national HIV planning or advisory committee, 3 CNE per year.
- Serving as a field representative on an AIDS Clinical Trials Group (ACTG) protocol team, 7 CNE per year.

Precepting activities

• Serving as a preceptor for new nurses, undergraduate/graduate nursing students, 2 CNE per year.

Volunteer nursing activities

A maximum of 7 CNE per year can be earned as a volunteer nurse.

Examples of acceptable volunteer activities where direct nursing care is provided include:

- Camp nursing for children with HIV, 1 CE for every 3 hours of volunteer nursing.
- Residential care facilities or homeless shelters where serviCNE for PWHIV are provided, 1 CE for every 3 hours of volunteer nursing.
- Serving as a nurse on the medical support team for AIDS Ride and/or AIDS Walk, 1 CE for every 3 hours of volunteer nursing.
